Mission Statement

The Housing and Residential Learning Department seeks to create an optimal living environment for each resident student through departmental interaction with outside service-oriented agencies and all internal College constituencies. Furthermore, the department develops social and educational programs in the residence halls to foster a strong sense of community and encourage the personal development of each resident student.

STUDENT EXPECTATIONS

Every Albright College resident should expect to:

- Be free from fear or intimidation and physical or emotional harm
- Redress any and all grievances with resident assistants and/or Housing Office staff
- Be provided a clean building and room in which to live
- Have one's personal belongings respected by all who enter the room or building
- Live in a smoke-free/substance-free environment in all buildings/areas that are so designated
- Have all repairs or service orders attended to in a timely manner
- Host guests in accordance with the guest policy in effect
- Be assigned to rooms that are appropriately and adequately furnished
- Enjoy a quiet environment for study during appropriate hours as posted in College publications
- Decorate residence hall rooms within the guidelines specified in *Community Living: Your Guide to Living on Campus*

Failure to adhere to the residence hall policies as outlined in *Community Living: A Guide to Residence Halls* and the *Albright College Compass* may result in an intervention by the Office of Community Standards or your removal from College housing. See your resident assistant in your building or any College housing official if you have questions regarding this information.

STUDENT RESPONSIBILITIES

Every Albright College resident has the responsibility to:

- Abide by all federal, commonwealth and local laws and understand that there are stringent penalties for tampering with fire safety equipment and failure to exit the building when the fire alarm sounds
- Fully realize that the use or possession of alcoholic beverages by anyone under the age of 21 is prohibited, as is the distribution, sale or provision of alcohol to persons under 21
- Take every precaution to ensure that College property is not abused or defaced and to report anyone engaging in such acts
- Understand that the College reserves the right for appropriate officials to enter, inspect and search any room or apartment at any time
- Report any person or persons who may present a threat to the safety of students or College personnel
- Refrain from propping entrance doors and to close any door left in such a manner
- Take all personal room trash to the appropriate location outside the building
- Escort and supervise guests at all times when they are in the residence hall
- Refrain from smoking in all areas that are designated as smoke-free
- Keep your room door locked when you are asleep, in the shower, visiting, or anytime you are away from the room
